### **Description**

BPW24R is a high sensitive silicon planar photodiode in a standard TO–18 hermetically sealed metal case with a glass lens.






Figure 1. Reverse Dark Current vs. Ambient Temperature




Figure 2. Relative Reverse Light Current vs. Ambient Temperature




Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength





Figure 7. Relative Radiant Sensitivity vs. Angular Displacement


